# **Confidential Mayoral Minute**

### MM43/22 Confidential - Recruitment of General Manager (F2022/00641)

This matter is considered to be confidential under Section 10A(2) (d) Of the Local Government Act, as it deals with commercial information of a confidential nature that would, if disclosed (i) prejudice the commercial position of the person who supplied it; or (ii) confer a commercial advantage on a competitor of the Council; or (iii) reveal a trade secret.

## 303/22 **RESOLUTION: (Mayor, Cr Parker)** that Council:

- a) note the process for the recruitment and selection of the new General Manager as outlined in this Mayoral Minute;
- b) appoint a selection panel comprising:
  - 1. The Mayor
  - 2. Deputy Mayor
  - 3. a Liberal Councillor
  - 4. Carl Millington Chair of Council's Audit, Risk & Improvement Committee (as an independent advisory member of the panel)
  - 5. Judith Carpenter Recruitment consultant (as an independent advisory member of the panel);
- c) the selection panel will call a full briefing of all Councillors to hear presentations from the shortlisted candidate/candidates.
- note that an Extraordinary Meeting of Council be called for the purpose of considering a recommendation from the selection panel on the appointment of the new General Manager; and
- e) pursuant to sections 336 and 351 of the Local Government Act 1993, appoints Kerry Kyriacou to be the Council's Acting General Manager from November 4 onwards until the commencement of a new General Manager or until further decision of the Council, whichever occurs first.
