Director City Planning Report - Results of Community Consultation on Continuing Randwick's Environmental Levy (Special Rate Variation) on a Permanent Basis and Adoption of the Long Term Financial Plan (LTFP) 2023-2033 (F2019/00323)

1/24 **RESOLUTION: (Olive/D'Souza)** that Council:

- notes the extensive consultation carried out with the Randwick community on the proposal to continue Randwick's Environmental Levy Special Rate Variation (SRV);
- b) applies to IPART for a single-year increase under section 508(2) to incorporate the Environmental Levy into the rating structure on a permanent basis resulting in Special Rate Variation application for an increase of 11.67% including the rate peg at 4.90%;
- notes that IPART will also place Randwick's application on exhibition for public comment from March to April 2024, before providing its determination on Randwick's proposal for the permanent Environmental Levy; and
- d) adopt the updated Long Term Financial Plan 2023-33.

MOTION: (Olive/D'Souza) CARRIED - SEE RESOLUTION.

AMENDMENT: (Hay/Burst) that Council:

- a) notes the extensive consultation carried out with the Randwick community on the proposal to continue Randwick's Environmental Levy Special Rate Variation (SRV);
- b) applies to IPART for a single-year increase under section 508(2) to incorporate the Environmental Levy into the rating structure for a period of ten years resulting in Special Rate Variation application for an increase of 11.67% including the rate peg at 4.90%;
- notes that IPART will also place Randwick's application on exhibition for public comment from March to April 2024, before providing its determination on Randwick's proposal for the temporary Environmental Levy;
- d) adopt the updated Long Term Financial Plan 2023-33;
- e) endorse that the project plan for the environment levy change its scope, to target infrastructure spending and easing the cost of living crisis, particularly with regard to construction of stormwater drainage design. The estimates in the five year plan should be varied from what is written on pages 14 and 15 of this business report to instead read:
 - Community Education \$0 (was \$4.5M):
 - Water Savings \$0M (was \$2m), though the funding could be restored if it looks like we could be entering a drought;
 - Climate & Resilience \$1.5M (was \$5.5M), to only be allocated to rebates, microgrid investigations and a Power Purchasing Agreement as these can ease the burden of increased living expenses;
 - Food \$0 (was \$2M);
 - Active Transport \$0 (was \$4M);
 - Other \$0 (was \$2M);
 - Stormwater and Drainage \$20M, to be spent on infrastructure design and major works;
 and
- f) that in five years' time, a report be prepared allowing councillors to discuss and allocate funding for the next five years. LOST.

Note: Crs Burst, Hay and Rosenfeld requested that their names be recorded as opposed to the resolution.

There being no further business, Her Worship the Mayor, Cr P Veitch, declared the meeting closed at 7.37pm.
