Additionally, if a prospective participant wished to make a PowerPoint (or similar) presentation to the Committee, such presentation must be emailed to the Council at least 24 hours prior to the meeting.

### **Traffic Committee**

The following information is provided so that you may be aware of the structure and operation of the Randwick City Traffic Committee.

- The Randwick Traffic Committee is a Committee of Randwick City Council but not one set up under the Local Government Act.
- Council has been delegated certain powers, from Transport for NSW (TfNSW), with regard to traffic matters upon its local roads. A condition of this delegation is that Council must take into account the Traffic Committee recommendations.
- Recommendations in this document may either activate the formal delegation from Transport for NSW to the Council, or not activate this delegation. Items which activate the delegation are indicated with the initials (AD) below the heading.
- There are four permanent members of the Traffic Committee, each of whom has a single vote only.
- The members are: the NSW Police Service, Transport for NSW, the Local State Member of Parliament (for the location of the issue to be voted upon) and Randwick City Council.
- Randwick City Council welcomes the public to attend and speak at its Traffic Committee on issues of concern.
- If the Local Member disagrees with any of the Traffic Committee recommendations, they may appeal to Transport for NSW or the Minister for Roads.
- If the Police or Transport for NSW disagrees with any of the Traffic Committee recommendations, or Council's resolution on any Traffic Committee recommendation, they may lodge an appeal with the Sydney Regional Traffic Committee for determination. The appeal must be lodged in writing within 14 days of the notification to the members of Council's decision on the recommendation.
- Any action relative to any issue under appeal must cease until the matter is determined.
- The Sydney Regional Traffic Committee is chaired by an independent chairperson and submissions and representations are welcomed from all interested parties.

Randwick Traffic Committee is a Committee of Randwick City Council. Accordingly, all participants are expected to comply with the Council's Code of Conduct. Details of the Code of Conduct can be accessed by CLICKING HERE.


# Subject: Barker Street at Perouse Road, Randwick (C)

A few residents have raised concerns regarding the pedestrian safety at the intersection of Barker Street and Perouse Road, Randwick. Their concerns related to their inability, as a northbound Perouse Road pedestrian crossing Barker Street, to see northbound Perouse Road vehicles approaching the roundabout.

To address the safety concern, kerb buildouts and redesigning of the splitter islands in Barker Street are proposed. Kerb realignment on the southwestern side of Barker Street will physically narrow the travel lane. This will improve sightlines for pedestrians and motorists and induce a slower left turning movement from Perouse Road into Barker Street.

A concept design with swept path diagrams is shown below.



### **Resourcing Strategy implications**

Funding is provided for within the current budget; under the 'Traffic Committee Works' allocation.

### Recommendation

That the proposed redesigning of splitter islands, kerb buildouts and accompanying signage/line marking in Barker Street at Perouse Road intersection be approved for installation.

# Subject: Coogee Christmas Carols 2024 - Temporary Road Closures (C)

Similar to previous years, Randwick Council will once again be holding the popular Coogee Carols event, on Sunday 15 December 2024 from 6.30pm–8.30pm. This free-entry event attracts crowds of approximately 5,000-10,000 and therefore require traffic management, inclusive of several road closures, to safely manage the departure of attendees and other road users at the conclusion of the event.

Council is currently in the process of procuring traffic management plans (TMPs) and Traffic Guidance Schemes (TGS) for this event. As per previous years, the closures will be implemented by Eastern Beaches Police Area Command, with whom planning discussions have commenced. Upon receiving detailed TMPs and TGS, Council will consult with the Traffic Committee Technical Sub-Committee to obtain final approval.

In the meantime, in-principal support is sought regarding the proposed temporary road closures and associated traffic management measures described below.

### **Coogee Carols**

Date: Sunday 15 December 2024

Location: Goldstein Reserve, Coogee Beach

**Event purpose**: The Coogee Carols are an annual event held at Coogee Beach, presented by Randwick City Council. The Carols are a very popular event, especially with families who are looking for an alternative to the "Carols in the Domain". The Carols are loved as an event that is local, laid-back, and held in a stunning location. Despite the beachy nature of the event, the show is of a very professional standard. The event consists of live performances, Santa visit and a short 5-minute fireworks display at the conclusion of the event.

Road closure plans: As per 2023, the road closure for Coogee Carols is designated as a precautionary public safety measure by the Police. The road closure will be executed by the Police on the night, eliminating the need for traffic controllers. However, Randwick City Councill will engage a traffic management company for a TMP and TGS and equipment for the temporary closure of Arden Street, Coogee, stretching from Bream Street to Carr Street. Additionally, Coogee Bay Road (before Vicar Street, east end of street), Alfreda Road (after pedestrian crossing on east end of street), Dolphin Street (before Hill Street, east end of street) will be partly closed to support the Arden Street Road closure. Road closures are scheduled from 8:00pm–9:15pm, coinciding with the conclusion of the event.

Once a traffic management company is appointed, Council will also investigate practicality of and options for changing the time of the road closure in the event of poor weather resulting in an earlier finish of the event, as almost happened in 2023. Buses are permitted through the closures on Arden Street and Bus stops on Arden Street will be operational as usual. For the 2024 Event, the only change is that the Police have recommended closing Dolphin Street, east of Arden Street, starting at 4:30 PM, and redirecting traffic to Arden St or Dolphin St to reduce congestion into the closed car park.

### **Resourcing Strategy implications**

This event is included in the current 2024/25 Economic Development and Placemaking budget, within the 'Events' budget allocation.

### Recommendation

That, the described road closures and associated traffic management measures for the Coogee Carols 2024 event be supported in principle, with final approval of each TMP to be subject to consultation with the technical Sub-Committee.

The annual Christmas street party of St Lukes Anglican Church, at Clovelly, is scheduled for Sunday, 1st of December 2024, from noon till 9pm. As per previous years, the church has requested consideration of a temporary road closure of Varna Street, between Carlton Street and Arden Street.



Randwick Council is supportive of small street parties which contribute to the overall sense of community for our residents. Since the diversion routes fall within the Waverley Council area, therefore, it is suggested that approval be sought from Waverley Council as well.



### **Resourcing Strategy implications**

Funding is provided for within the current budget; under the 'Signs and Lines' allocation.

### Recommendation

That approval be granted for the temporary road closure of Varna Street, Clovelly, on Sunday, 1st of December 2024, between noon and 9pm, to facilitate a Street Party, provided that the following conditions are adhered to:

- a) Waverley Council be notified about the road closure and approval be sought regarding the proposed diversion routes;
- b) The Council prepares a traffic control plan in accordance with the relevant guidelines and standards showing the location of barricades, 'Detour' signs, 'Road Closed Ahead' signs, and other relevant signs;
- c) The Council shall close the roads in accordance with the approved traffic control plan, unless otherwise directed by Police;
- d) The applicant shall not occupy the carriageway or footway of the road until the road closure has been effected, in accordance with the approved plan;
- e) All traffic control devices will be installed in accordance with Australian Standard 1742.3;
- f) No fixtures of a permanent nature shall be located on the public way;
- g) At all times, access to adjoining premises in the proposed street closure shall be maintained to the satisfaction of the Emergency Services (i.e. at least a 3-metre wide 'clear path' shall be retained - clear of any installation - in the event that emergency services access is required). All services (fire hydrants etc.) shall be kept free of any obstructions;
- h) All barriers and signs associated with the road closure shall be removed at the times nominated to reopen the street to traffic;

- i) The applicant shall be responsible for the reimbursement for the cost of repair of any damage caused to the public way, or as a result of the activities;
- j) The applicant shall comply with any reasonable request or direction of City Rangers, other Council staff or the Police;
- k) Council reserves the right to cancel or amend the conditions of approval at any time.
- I) The event organiser is to be in regular contact with Council's authorised traffic controller(s);
- m) During the event, the event organizer must have the Traffic Control Plan (TCP) and the approval letter available;
- n) All attendees comply with the approved TCP;
- o) Noise generated by the street party is controlled in accordance with the Protection of the Environment Operations (Noise Control) Regulation 2000;
- p) The area is maintained in a clean and tidy condition; and

It is clearly understood that non-compliance with any of the abovementioned conditions may result in immediate cancellation of the approval and the event.

# Subject: Kensington Park - Parking Restrictions for West Carpark (W)

Concerns have been raised by a local resident regarding vehicles parking all day within the Kensington Park carpark with limited turnover, resulting in difficulty finding parking for users of the oval/park. It was requested that Council explore introducing timed parking to encourage turnover of this carpark.

It is proposed that five of the existing parking spaces located within the western carpark at Kensington Oval be signposted '2P 9am-6pm Mon-Fri'. The proposed location for the time restricted parking spaces is depicted in the figure below.



Figure 1: Proposed parking spaces to be signposted '2P 9am-6pm Mon-Fri'.

Council has reached out to three regular groups who hire Kensington Park to determine the demands of larger groups that utilise the oval within the park. To date we have received two responses which have raised no objection to the proposal.

The proposed changes to introduce time restricted parking for five spaces will support increased turnover of the carpark which will help to support residents and sporting groups that currently utilise the oval for recreational uses.

# Subject: Fennelly Street, Randwick - Temporary School Bus Zone (W)

School Infrastructure NSW has sought the assistance of Randwick Council as it manages the commencement of 2025 classes, at the new Green Square Public School.

Unfortunately, due to a number of unforeseen factors, the planned opening of the new school has been set back from February to August / September 2025. This has resulted in significant numbers of newly enrolled primary school students not having a school to commence the school year.

To address this matter the NSW Education Department has arranged for the use of available space at Rainbow Street Public School (PS), whilst the Green Square PS is being completed. Operationally, it is planned that the Green Square PS children will meet at the site of their new school. They will then board a special school bus and be delivered safely to Rainbow Street PS. In the afternoon the special school bus will pick up the children from Rainbow Street PS and be delivered back to the Green Street PS site.

The Principal of Rainbow Street Public School is fully supportive of the proposal and is very willing to assist the new school with these temporary arrangements.

School Infrastructure NSW has explored the options for the location of a special school bus stop to manage this proposal. Ultimately, following discussions with Council officers, it has been agreed that the best location for a temporary school bus stop will be at the rear of the school, in Fennelly Street (see diagram on following page).

These temporary arrangements will result in the unavailability of some 4 or 5 car parking spaces, during school drop off and pick up times, on school days. Outside of these hours the parking will be available. Once the temporary arrangements are no longer required, the special school bus zone will be removed.

That:


- a) A 25.5m long, temporary School Bus Zone, 8am-9:30am, 2:30pm-4pm, School Days, be created on the southern side of Fennelly Street, Randwick, from the western end of the widened footpath to the eastern edge of the driveway leading to the community garden.
- b) The temporary School Bus Zone be removed from Fennelly Street once it is longer required.

As part of Council's commitment to building "a sense of community", Randwick Council has, for some years, supported and encouraged a small number of neighborhoods street parties, toward the end of the year. To safely close the road, and to facilitate street parties, an appropriate traffic guidance scheme needs to be implemented. Over the years the council has been assisting applicants by arranging, on behalf of the residents, all traffic control measures associated with the street parties.

To date, Council has received a single application for a Christmas Street Party. It is however anticipated that further applications may be received (last year there were 18 applications) and these would be submitted to the December 2024 Local Traffic Committee meeting.

It is recommended that approval be granted for the temporary road closure of the local streets outlined as per the following table. The Traffic Guidance Scheme (TGS) for the event is also included following the table.




Figure 1: Holden Street, Maroubra

### **Street Party Conditions:**

The following standard conditions apply to the organisers of a Street Party:

- 1. The event is a private street party which is only open to the residents of the closed streets and their guests.
- 2. The traffic control associated with the temporary road closure of the closed street is implemented on the approved date for the approved times ONLY.
- 3. The event organizer is to be in regular contact with Council's authorized traffic controller(s), be in possession of the Traffic Guidance Scheme (TGS) prepared by Randwick Council and be in possession of this approved letter.
- 4. That all attendees comply with the TGS prepared by Randwick Council.
- 5. That noise generated by the street party is controlled in accordance with the Protection of the Environment Operations (Noise Control) Regulation 2000.
- 6. That all attendees comply with the directives of Council staff and the NSW Police.
- 7. The area and all facilities must be maintained in a clean and tidy condition, and the area/ facilities must be thoroughly cleaned up immediately after the activity, to the satisfaction of Council.
- 8. The Council expressly reserve es the right in its absolute discretion to refuse to accept any engagement and the Council shall not be liable in any way for any loss or damage or otherwise in consequence of the exercise of this right.
- 9. All engagements are accepted conditionally upon compliance by the hirer with requirements of the Local Government Act and any other relevant Act or Regulation.
- 10. The hirer hereby grants the Council an indemnity and releases Council from all claims, demands, remedies, suits, injuries, damage, losses, costs, liabilities, actions, claims for compensation and the like for which Council may become liable in conjunction with injury, damage or accidental death neglect or default or the neglect or default of any other person in connection with use of the street.
- 11. Children must be always supervised by an Adult.
- 12. Should you wish to sell or supply alcohol you may require a Liquor License under the Liquor Act 2007 or for further information, please contact Liquor and Gaming NSW on 1300 024 720.
- 13. The consuming of alcohol must be compliant with the street signage. For example, no serving or drinking of alcohol can occur in designated "Alcohol-Free Zones".
- 14. A First Aid Kit must be made available, always.
- 15. All electrical cords must be kept away from walking areas.
- 16. Non-compliance with any of the abovementioned conditions will result in immediate cancellation of the approval.
- 17. Council approval only covers the area of road reserve, not private property. No liability extends to privately-owned land.

Construction sites often involve the use of trucks, cranes and other large vehicles. Without special parking provision, the positioning of such vehicles, close to these sites, can cause significant problems for local residents or businesses. It is for this reason that the Council requires the creation of Works Zones at construction sites. Once the project is completed the Works Zone is removed (see Works Zone Conditions of Use detailed elsewhere within this document).

Accordingly, it is recommended that Works Zones be installed, or removed, at the locations detailed within the following table:

### **Schedule Of Conditions - Installation of Works Zones**

The following standard conditions may be referenced within these papers. That:

- a. The applicant be informed that if they intend to use traffic controllers for activities associated with the Works Zone, such activities must comply with a formal Traffic Control Plan (to be held on site following preparation by person/s with the appropriate Transport for NSW (TfNSW) authorisation) and that any traffic controllers utilised must have current appropriate accreditation from TfNSW;
- b. The Council is given authority to replace the Works Zone with a No Stopping zone if the operator (or their sub-contractors):
  - i. compromise pedestrian and/or bicyclist safety, or
  - ii. add significantly to traffic congestion in this area, or
  - iii. allow access/egress to/from the site which creates safety concerns or traffic flow delays, or
  - iv. does not ensure that the Council fees payable for this private use of the public road are met,

with the zone being reinstalled once the issue of concern is properly addressed;

- c. The Council Rangers enforce the restriction; and
- d. Authority be given to the Council to remove the Works Zone and reinstate the previous restrictions, when the applicant advises that it is no longer required.

The Council regularly receives requests for action to be taken with regard to vehicles being parked illegally at intersections. Such vehicles block sightlines to and from vulnerable road users such as pedestrians or bike riders. They can also obscure motorists' views of approaching vehicles, and, they can create difficulties for fire engines, garbage trucks or other large service vehicles which need to access the neighbourhood.

To ensure compliance with the legally mandated parking prohibitions at intersections, it is recommended that No Stopping signage be installed as per the following table:

The State Government provides regular funding under a number of programs for road safety and active transport (walking and bike riding) improvements. Randwick Council was successful in securing funding for a number of projects for the 2022/2023, 2023/2024 and 2024/2025 financial years. The total of TfNSW funds secured by Randwick Council, and indicated in the following table, exceeds \$ 17.6M.

These funds are made available through Transport for NSW (TfNSW). Additionally, Federal Government funding has also been made available under the federal Black Spot Program. Apart from the Anzac Paths Project (APP), all listed projects are 100% externally funded (APP is funded on a 50/50 basis). The following table shows the status of currently approved projects.
