#### **Traffic Committee**

The following information is provided so that you may be aware of the structure and operation of the Randwick City Traffic Committee.

- The Randwick Traffic Committee is a Committee of Randwick City Council but not one set up under the Local Government Act.
- Council has been delegated certain powers, from Transport for NSW (TfNSW), with regard to traffic matters upon its local roads. A condition of this delegation is that Council must take into account the Traffic Committee recommendations.
- Recommendations in this document may either activate the formal delegation from Transport for NSW to the Council, or not activate this delegation. Items which activate the delegation are indicated with the initials (AD) below the heading.
- There are four permanent members of the Traffic Committee, each of whom has a single vote only.
- The members are: the NSW Police Service, Transport for NSW, the Local State Member of Parliament (for the location of the issue to be voted upon) and Randwick City Council.
- Randwick City Council welcomes the public to attend and speak at its Traffic Committee on issues of concern
- If the Local Member disagrees with any of the Traffic Committee recommendations, they may appeal to Transport for NSW or the Minister for Roads.
- If the Police or Transport for NSW disagrees with any of the Traffic Committee recommendations, or Council's resolution on any Traffic Committee recommendation, they may lodge an appeal with the Sydney Regional Traffic Committee for determination. The appeal must be lodged in writing within 14 days of the notification to the members of Council's decision on the recommendation.
- Any action relative to any issue under appeal must cease until the matter is determined.
- The Sydney Regional Traffic Committee is chaired by an independent chairperson and submissions and representations are welcomed from all interested parties.

Randwick Traffic Committee is a Committee of Randwick City Council. Accordingly, all participants are expected to comply with the Council's Code of Conduct. Details of the Code of Conduct can be accessed by CLICKING HERE.

Subject: Bell Lane, Randwick – "SLOW" Linemarking (C)

Recurring concerns have been raised by some local residents and businesses associated with driving along Bell Lane, Randwick. Primarily these concerns relate to motorists negotiating the 65° bend in Bell Lane at an inappropriate speed. Given the very narrow characteristics of Bell Lane and given the numerous driveways providing access from the lane, the installation of regular warning signs is just not viable. Given these unique circumstances, it is proposed to install road markings indicating "SLOW" at a minimum of 10m on approach to the bend, as illustrated in the diagram below. With this proposal motorist will be reminded of the 'blind' bend and may reduce their speed when manoeuvring around the bend of Bell Lane.

## Subject: Coogee Sparkles, Coogee – New Year's Eve Event (C)

Each year, Council organises the popular 'Coogee Sparkles' New Year's Eve 9pm Fireworks. The free-entry event attracts crowds of up to 25,000. Accordingly, traffic management is introduced each year, inclusive of several road closures, to safely manage attendees and other road users.

Council is currently in the process of procuring traffic management plans (TMPs) and Traffic Guidance Scheme (TGS) for this event. Upon receipt of these documents the Council will consult with the Traffic Committee Technical Sub-Committee (TfNSW / Police) to obtain final approval.

In the meantime, Council is seeking in-principle support from the Traffic Committee for the regular road closures and associated traffic management measures as described below.

Date: Tuesday, 31st of December 2024

Location: Goldstein Reserve, Coogee Beach

<u>Event Purpose</u>: To celebrate 2024 and welcome in the new year 2025. Roving entertainment from 2pm and 15-minutes fireworks display at 9pm.

Road closure plans: refer to TfNSW map for Coogee Sparkles 2024 road closure plan on Google My Maps

The proposed road closures are similar to 2023 but with changes to the times with road closures proposed from 5:30pm – 10:30pm, special event clearways from 12noon – 10:30pm on Brook Street for Police vehicle parking and 4:00pm – 10:30pm on all other streets, and bus diversions from 5.30pm – 11pm.

Timings of the clearways and closures will be 5pm - 10.30pm. It has been determined that a shorter time between commencement of clearways and the road closures is needed to reduce illegal parking and towing prior to closure being implemented. Road closures are again being brought in earlier (this year from 5.30pm - 10.30pm, rather than 7pm - 10pm in 2022) in response to crowd arrival times and being held longer in line with actual re-opening times in 2023.

Following a number of community requests, a proposal has been prepared to implement a north / south pathway, in Paine Reserve, Randwick. Paine Reserve is located to the east of Botany Street, at Rainbow Street.

It is proposed that this path be formally designated as a Shared Path. The term "Shared Path" indicates a properly signposted / linemarked area open to the public that is designated for, or has as one of its main uses, use by both pedestrians and the riders of bicycles. The plans detailing the proposed path markings and signage will be tabled at the meeting.

The 'Step Out Speak Out' event will be held on Friday 22<sup>nd</sup> of November 2024. Council will be collaborating with the NSW Police Force to promote the elimination of domestic violence. The Police will be closing Coogee Bay Road to westbound traffic for approximately 90 minutes, from 7:00am. Eastbound traffic on Coogee Bay Road will be allowed to continue until the March comes within a block of the traffic, at which time the traffic controllers and police will prevent traffic from entering Coogee Bay Road.

In addition, to facilitate passenger drops-offs, mounted police parking and to provide an area for participants to form up at the start point for the Step Out Speak Out 2024, the parking needs to be restricted on the north/east and south/west of Belmore Road, Randwick between Avoca Street and Coogee Bay Road / Perouse Road. It is proposed to utilise the southern kerbside lane (lane 4) for passenger drop-off, with lane 1 for mounted police parking. At 7am, lanes 2 and 3 will be closed to traffic for the formation of the walk. Once walk and end vehicle passes Perouse Road and Cuthill Street, Belmore Road will reopen to traffic.

Police will manage the intersection of Arden Street and Coogee Bay Road, allowing Transdev buses access westbound to Brook Street, only holding the buses when the March gets close.



It has been agreed that the buses will be allowed through Belmore Road until the march begins at 7:15am.

- 2. VIP and courtesy bus drop-offs to remain on Belmore Road but will not be allowed after 7:15am.
- Strictly no vehicle access from 7:15am to 7:30am on both Belmore Road and Coogee Bay Road.

4. VMS boards installed from the morning of Monday 18<sup>th</sup> November 2024 to Friday 22<sup>nd</sup> November 2024 until 12pm at the following locations:

1 x VMS Board - Opposite Randwick Royal Hotel Randwick. Top of Coogee Bay Road

Perouse Road - In High Cross Park facing On-coming traffic.

1 x VMS Board - Bottom of Coogee Bay Road facing straight up the road.

Message: STEP OUT SPEAK OUT EVENT FRI 22 NOV 7AM – 9AM EXPECT DELAYS

## Subject: High Street, Randwick - Cycleway Kerb Nib

The High Street pop-up cycleway was implemented in April 2021, as a covid innovation. The cycleway terminates just east of the signalised intersection of the Australian Turf Club driveway / UNSW Gate 5 / High Street, and it has a temporary waterfilled barrier which holds unidirectional hazard markers to guide both bike riders and motorists. The barrier was initially implemented as a temporary solution however it requires frequent maintenance, particularly after periods of heavy traffic, weather events, or when displaced by persons unknown. The use of water-filled barriers is labour-intensive as the facility must be regularly checked, refilled, and repositioned to ensure road safety effectiveness.



Figure 1: Kerb Blister and Associated Signs and Lines Concept plan – High Street near Gate 5 UNSW




Figure 1: Example Designated Parking Signage

A permanent kerb nib is proposed - as indicated in Figure 1. The kerb nib will serve as a permanent fixture and guide drivers to merge right. It also provides a physical separation between vehicles and cyclists. The kerb nib will feature low-maintenance planting to improve aesthetics, with unidirectional hazard chevron markers (D4-1-1(R)) to guide eastbound and westbound road users.

As the proposed kerb nib is in close proximity to traffic signals, Council has consulted with Transport for NSW. As indicated in Figure 1, a "Merge Right" (W8-15) sign and a pavement arrow stencil, to indicate motorists have to merge right are proposed. These will be placed at strategic points leading up to the lane closure to warn drivers in advance that the lane ahead is ending and that they must merge into the right lane. This allows drivers ample time to adjust their position, on this 40km/h speed limit road.

Safety improvements are also planned for the cycleway. Currently, cyclists travelling westbound lack sufficient guidance at this end of the cycle path which may lead to possible confusion. To mitigate this risk, a "Give Way" line and a turning arrow pavement stencil will be marked on the cycleway to indicate that westbound riders must yield to approaching eastbound bike riders.

## **Subject:** Boronia Street, Kensington - Motorcycle Parking (H)

Due to high demand for motorcycle parking mid-way along Boronia Street and in response to residents' requests, an examination was undertaken into the installation of motorcycle parking in the area. This motorcycle parking layout will require the removal of one 90° angled on-street parking space, as depicted in the figure below.

In accordance with Australian Standards AS2890.5:2020, surface grades should be less than 1 in 20 (5%) to prevent parked motorcycles from capsizing. The section of the road that complies with the maximum grade for motorcycle parking is at the frontage of 28-32 Boronia Street, as indicated in the figure below.

#### Recommendation

That a single 90° angled on-street parking on the west side of Boronia Street, Kensington, directly south of the driveway leading to nos 28-32, be replaced with four motorcycle parking spaces as indicated in the diagram within this report.

Concerns have been raised from residents of Harold Street, between McCauley Street and Bunnerong Road, Matraville, regarding road safety and incidences of motorists speeding through the street. In response to these concerns, a traffic volume and speed count was undertaken near 45 Harold Street, Matraville. The data arising from this traffic count is presented in the table below.

Traffic counts were undertaken from 6<sup>th</sup> August 2024 for a seven-day period to determine the extent of the speeding issue. The data highlights that the average daily traffic volumes are typical of such locations within the urban environment and the 85th percentile speed is slightly above the posted speed limit 50km/h.

Given this outcome, Council will forward the results of this traffic count, together with a request for possible speed enforcement along Harold Street, to the local Police Highway Patrol.

On Sunday 27<sup>th</sup> October 2024, the annual Maroubra Fun Run will be held along a number of streets in the Maroubra Beach area.

Localised road closures will be in place from 8:30 am until 11am. The most critical road closure will be the southbound carriageway of Malabar Road, from Fitzgerald Avenue to Beauchamp Road. Traffic in this section will be diverted via New Orleans Crescent and Chicago Avenue back to Beauchamp Road.

The traffic management for the event will operate as per recent years' arrangements. Police are proposed to be positioned at other critical intersections where traffic from side streets conflicts with the runners. 

## Introduction / Background

New electric vehicle (EV) chargers are proposed to be installed across Waverley, Woollahra, and Randwick Local Government Areas (LGAs) to support the rapid increase of electric vehicles. The installation of chargers is supported by the Eastern Suburbs Electric Vehicle Infrastructure Strategy 2023 adopted by Randwick Council in 2023. This Strategy outlines the vision and infrastructure required to meet growing numbers of EVs on our roads.

There are currently 4,000 EVs registered in Waverley, Woollahra, and Randwick LGAs. This number is projected to increase to over 10,000 by 2025, and to more than 35,000 by 2030. These proposed chargers will be funded through the NSW Government Kerbside Charging Grants and will be installed, owned and managed by private companies PLUS ES, EVX and EVIE under licence. These private companies will also be responsible for the installation of Council approved linemarking and signage.

The charging stations to be installed include a mixture of designated and undesignated charging spaces. The designated electric vehicle charging spaces include a charger, as well as parking signage and linemarking. These spaces are for electric vehicles only while charging. Some charging spaces, such as some of those provided by PLUS ES, are undesignated. Any vehicle, including non-electric vehicles, may park in the undesignated spaces.

Round 1 of the EV charging spaces included 12 proposed public electric vehicle charging stations in the Randwick LGA.

#### Consultation

The community consultation for proposed Round 1 public electric vehicle charging locations was undertaken by Council officers for a period of 28 days from 6 August 2024 - 3 September 2024. Consultation activities included signage installed at the proposed locations, letter drops to nearby residents and online promotions through eNews and social media. All communications directed residents to a 'Have Your Say' page shared by Waverley, Woollahra and Randwick Councils. This Have Your Say page included an interactive map for residents to review the proposed locations and write comments.

Council received 333 submissions via the Have Your Say page and via emails and phone calls. A summary of consultation results for each charger can be found in *Table 1 – Charging Station Locations*. In total across the Eastern Suburbs there were 98 supportive submissions, 216 unsupportive submissions, and 19 enquiries.

Based on the community feedback received, Council officers have recommend to either proceed, or not proceed, with parking control changes at each of the sites investigated. Of the 12 proposed electric vehicle charging stations in Randwick, it was recommended that electric vehicle parking signage be installed at 5 of these sites. Alternative sites are being examined near to other proposed locations which have now been deleted, following consultation.

A summary of the consultation outcomes for each of the original recommendations can be found below in Table 1 – Charging Station Locations. Note only 5 sites are recommended for parking control modification.

Note that for some sites where changes to parking restrictions are not recommended, an alternative location has been suggested by the community. The community consultation for these alternative sites (Round 2) will take place in October 2024.

Also note that at some locations it was found that an 'undesignated' charging space was more suitable than a designated charging space. For undesignated charging spaces, a charger is installed but there is no change in parking restrictions. Private companies can install charging stations on street poles as such installations are exempt development under clause 2.124E of the State Environmental Planning Policy (Transport and Infrastructure) 2021.

## **Parking Signage**

The electric vehicle parking signage is as per the Traffic Committee recommended and endorsed EV parking signage code 'R5-1-12n' to ensure that only EVs occupy the parking space only while charging as shown below in Figure 1 (Traffic Committee Report No. TC63/24, held on 14 May 2024).

#### Linemarking




Figure 2: Recommended Linemarking

The recommended linemarking for designated charging spaces is shown in Figure 2. This is based on the Transport for NSW Electric Vehicle Pavement Marking, which is the same design but with a blue logo instead of green. A green has instead been recommended based on consultation with transport officers which found that the blue colour may cause confusion due to its similarities to the disabled linemarking design.

The private charging companies will also pay council an annual fee for designated charging spaces. The details of this arrangement are expected to be finalised by November 2024.

  - iii. allow access/egress to/from the site which creates safety concerns or traffic flow delays, or

The Council regularly receives requests for action to be taken with regard to vehicles being parked illegally at intersections. Such vehicles block sightlines to and from vulnerable road users such as pedestrians or bike riders. They can also obscure motorists' views of approaching vehicles, and, they can create difficulties for fire engines, garbage trucks or other large service vehicles which need to access the neighbourhood.

To ensure compliance with the legally mandated parking prohibitions at intersections, it is recommended that No Stopping signage be installed as per the following table:
